












# FORMER MCAS MARINE CORPS BASE 5 POINTS HERITAGE PARK – EL TORO MARINE BASE, IRVINE ORANGE COUNTY GREAT PARK

April 2017 - October 2017 | Contract Amount: \$3,470,503.48

Consisted of end-dump transportation of 211,082 tons of non-hazardous soil. B&D Equipment Rental encompassed over 1,300 acres. Specially equipped trucks were dispatched to transport soil subject to agency conditions. With the hauling, a certificate of destruction of fiberglass UST was provided. There was also on-site truck routing to specific project loading areas for segregated contaminated soil loading, as required by agency regulations. In total, 319,592 miles were safely traveled from haulers without any incidents.
